II. HAZARDS IDENTIFICATION

Routes of Entry: Skin contact
Target Organs: Skin
Chemical Interactions: No chemical interaction known to affect toxicity.
Conditions Aggravated by Exposure: Personnel with pre-existing skin disorders should avoid contact with this product.

Acute Health Effects:

IV. FIRST-AID MEASURES

Summary:	
Extinguishing Media:	Use alcohol resistant foam, carbon dioxide, or dry chemical when fighting fires.
